The city attorney gave an overview of work completed regarding the Country Aire Section 2 Final Plat.

Council member Stanzel introduced, read & moved for passage of Resolution No. 2019-49 to approve the Final Plat of Country Aire Section 2. Ueckert seconded. All in favor, motion carried. A true, correct & complete copy is on file at city hall.

Council member Grove introduced, read and moved for passage of Resolution No. 2019-47 to authorize Mayor Smith to execute and sign the Country Aire Section 2 subdivision agreement. Stanzel seconded. All in favor, motion carried. A true, correct & complete copy is on file at city hall.

Council member Stanzel introduced, read & moved for passage of Resolution No. 2019-48 to authorize Mayor Smith to execute and sign the Drainage Easement for the Country Aire Section 2 subdivision. Grove seconded. All in favor, motion carried. A true, correct & complete copy is on file at city hall.

Council member Lewis moved to table action on Ordinance No. 728. Stanzel seconded. All in favor, motion carried.

Council member Stanzel moved to table action on Ordinance No. 729. Grove seconded. All in favor, motion carried.

City Engineer -

- a. Flat Water Phase 1 Greg Perry reported that dredging and grading are complete and they anticipate start- up of the lift station shortly.
- b. 2019 Flood Recovery Sewer CCTV Project Jim Olmsted reported that USG has completed most of the televising except under Gardiner Street due to the high volumes of water still in the line. The next phase of the project will be addressing damages found and repairs. Council member Lewis moved to authorize payment of \$31,554.90 to USG. Grove seconded. All in favor. Motion carried.

- c. 2019 Flood Recovery Gardiner Street Storm water Pumping Station Jim Olmsted gave an update on the scope of the project and presented a Notice to Contractors to solicit sealed bids. Council member Lewis moved to authorize the advertisement for bids for the project. Grove seconded. All in favor, motion carried.
- d. 2019 Flood Recovery Valmont Lift Station Mr. Olmsted gave an update on the scope of the project and presented a Notice to Contractors to solicit sealed bids. Council member Stanzel moved to authorize the advertisement for bids for the project. Lewis seconded. All in favor, motion carried.
- e. 2019 Ball Field Restoration Project Mr. Olmsted informed that this project is still being reviewed.
- f. 2019 Flood Recovery Pines Culvert/Intersection Replacement Mr. Olmsted reported that this project is complete except for the concrete work.
- g. 2019 Flood Recovery Front Street Pavement Reconstruction Mr. Olmsted gave an update on the scope of the project and presented a Notice to Contractors to solicit sealed bids. Council member Grove moved to authorize the advertisement for bids. Lewis seconded. All in favor, motion carried.
- h. Updates were given on these miscellaneous projects: Country Aire 2, Flatwater 2 & 3, Groundscapes and water main standard specifications.
- i. One & Six Year Plan Mr. Olmsted presented an updated map showing projects added to the one year portion of the plan. Council member Grove introduced, read and moved for passage of Resolution No. 2019-51 to adopt the 2019 One & Six Year Road Improvement Program. Ueckert seconded. All in favor, motion carried.

City Attorney – Mr. Farnham gave an update on the Valley Shores Street Assessments, Country Aire 2 and Flatwater Phase 2 and 3 subdivision agreements.

Mayor's Report – Planning Commission meeting is November 19, Valley Days meeting also November 19, Valley Days Foundation Christmas Tree Lighting Ceremony November 30, Christmas Tree recycling in city park December 26 – January 5. Keno receipts are steady. Sokol Camp resident applied for a building permit and it has been determined by the NRD that the area is part of the dike so he has been told he will have to backfill and compact the area back to its original state.

Council member Stanzel moved to go into executive session at 7:48 to discuss strategy regarding possible litigation relating to change orders submitted by Carstensen Contracting. Ueckert seconded. All in favor, motion carried.

Council member Grove moved to reconvene into open session at 8:15. Lewis seconded. All in favor, motion carried.
